ANNUAL REPORT AND STATISTICAL REPORT OF THE PRI-VACY ACT 2007-2008

INTRODUCTION

The *Privacy Act* provides citizens with the right to access personal information held by the government and protection of that information against unauthorized use and disclosure.

The National Battlefields Commission (NBC) is a agency subject to the *Privacy Act*. However, because of the scope of the Commission's activities, there have been few, if any requests under the *Privacy Act*, as attested by earlier statistical reports.

The NBC derives its mandate and powers from a 1908 Act of the Parliament of Canada, the *Act respecting The National Battlefields at Quebec*, 7-8 Edward VII, ch 57, and its amendments.

The NBC was established to acquire the historic battlefields of the city of Quebec and neighbouring communities, to create a national battlefields park and to conserve, develop these historic and urban parks.

DESCRIPTION OF THE STRUCTURE

All requests under this *Act* are forwarded to Financial Services, which has custody of individual files and sees that requests are processed within the prescribed deadlines.

DELEGATION ORDERS

The Chairman, the Secretary, the Assistant Secretary and the Financial Services Agent hold full authorities for the administration of the *Privacy Act*.

REQUEST RECEIVED

No request was received during the period covered, as stated in the appendix (statistical report) to the present report.

PRIVACY IMPACTS ASSESSMENTS (PIAs)

No new program or service has been developed. The Commission's program has not been substantially redesigned and the delivery mechanisms have not been changed. No impact was notified on the collection, use or disclosure of personal information neither on privacy issues.

No new data matching and data sharing activity was undertaking during the reporting period.
